



Dear Prospective Member,

Thank you for your interest in applying for Potomac Valley Watercolorists (PVW) membership. You can learn more about PVW at potomacvalleywatercolorists.org.

To apply for juried membership in PVW, you must submit the following items:

1. completed application (form attached here)
2. proof that you have had three different water media paintings (or predominately water media paintings with other supporting elements) accepted into three juried shows with three different judges within the last two years. Documentation may be Xerox of show catalogues, acceptance emails, program listings, etc.
3. brief resume of your art background.

Our selection committee meets in November of each year. At that time applicants are asked to physically submit three framed water media paintings completed within the last two years and showing artistic skill of high caliber. (They may or may not be the same paintings listed on your application.)

Please submit your best work. The panel of jurists will look for technical ability, originality, overall presentation, and consistency. These paintings must be **original work**, conceived by the artist and using the artist's own resources, and executed without the assistance of an instructor.

Send your completed application along with all documentation as described above, and a \$30.00 application fee (check made payable to PVW) to:

Applications with documentation should be received from September 15th through November 1st. Eligible applicants will receive instructions in early November with the specific date and place of the jurying.

PVW members are expected to actively participate in PVW's shows and supporting activities. Annual membership dues are \$60/yr. and payable on our website during January for the calendar year.
